ISSUE OF SHARES PURSUANT TO ASX LISTING RULES, NOTICE UNDER SECTION 708A

EnviroMission Limited ("EnviroMission") has issued 147,818,831 ordinary shares ("Shares") on 23 December 2008, in consideration for the acquisition of 58.92% of the issued and outstanding common shares of SolarMission Technologies Inc (SMT), and 100% of the issued and outstanding warrants in SMT to meet the terms of EnviroMission's share exchange offer to acquire majority control of SMT from eligible SMT security holders (share exchange offer closed 1 August, 2008).

These shares are now issued with shareholder approval granted at the 2008 Annual General Meeting held on 19 December, 2008.
